This 1844 book describes the workings of Parliament, including its constitution, powers and privileges, practice and proceedings, and private bills. The history and traditions of the institution are examined, and current practice explained in detail. It went into several subsequent editions, and was translated into many languages. Erskine May was also a cautious but efficient reformer, streamlining procedures in order to manage much greater amounts of parliamentary business: his work is still consulted on procedural matters.
